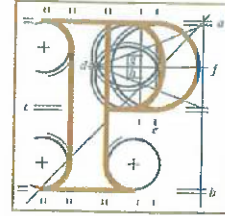

I refer to the Lyrenacarraige wind farm SID application currently under consideration (ABP-309121-21).
